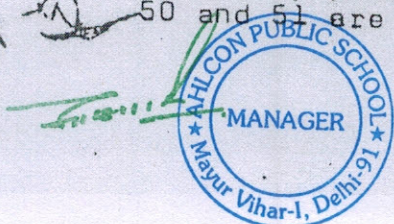
Subject: ISSUE OF ESSENTIALITY CERTIFICATE UNDER RULE 44
OF THE DELHI SCHOOL EDUCATION ACT & RULES, 1973.

Sir,

With reference to your application on the subject noted above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school at Patpar Ganj of (Bass-Yumna) from class 1st to XII without aid subject to the following conditions:-

1. That the provision of the DSEA, 1973 and the rules framed thereunder shall be observed by the society.
2. That the Management of the school will fulfill all the conditions laid down under Rule 50 and provide all the facilities given in Rule 51 of DSEA, 1973 to the institution.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed and prescribed Govt. scales alongwith all allowances will be paid to the teachers and non-teaching staff through crossed cheques.
5. That the management of the school will not ask for grant-in-aid from the Deptt.
6. That the school will not run for the profit of any individual association or group of persons.
7. That in case at any time, Management of the school is unable to run the school, moveable and immoveable property of the school will be transferred in the name of Director of Education, Delhi.
8. That the Management of the school will apply for grant of recognition of the school under DSEA & Rules, 1973 separately and recognition will not be granted unless statutory provision of Sec.4(i)(a-f) read with Rules, 50 and 51 are fulfilled.

9. That all the Recognised classes shall be run at one place only.
10. That the Management of the school will obtain land from the DDA in the name of the society.
11. That the school shall run under the Banner of Shanti Devi P. Progressive Education Society, B-4/205 Safdarjang Enclave, New Delhi-29 and suitable funds will be made available for the construction of suitable building on the land allotted to the society as declared, as per the specifications of the Department within a period of 2 years and adequate and sufficient accommodation 12 Sq.ft. per student shall be provided for class-room. The normal size of a class room is 24'x20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within the period of 3 years, this permission to open a new school shall be treated as cancelled.
